#### 1. Minutes

## 2. Old Business (Fundraising & Outdoor Ed)

- Read-A-Thon fundraiser happening February 19<sup>th</sup> 25<sup>th</sup>
  - Hard copy of all materials will be available for all students but everyone is encouraged to submit logs and donations online
  - o March 2<sup>nd</sup> Read Across America Day
- Book Fair happening February 1st 14th through Joseph Beth
  - Book Fair coupon applies to in store, curb side pick-up or online orders and works for all books, not just kid's books
  - Funds raised will be given to foundation via check
    - Previous years' Scholastic bookfair money \$175 is still available
      - Nicole Webb will use funds to purchase books to be given to 9-12 staff to pass out to their students who need reading materials for Read-a-thon
- Orton Gillingham training currently happening for two 6-9 staff members
  - Sarah Lofquist and Megan Kline are both enrolled and taking online classes covered by foundation
- Outdoor Education Imago
  - Foundation budget was cut this year by 1/3
    - Imago graciously accepted matching pay cut for this school year and has billed Foundation for their summer/fall work only
    - Spring work will be happening with or without payment, but being able to pay them for their work would be ideal

### 3. Treasurer's Report

- November and December financial reports sent by Tami Kauffman via email on January 18<sup>th</sup>
  - Bank statements were also attached to email statements were reviewed by Sara Bourgeois and Erin Spears

- PRM has already raised half of our fundraising goal set for this school year!!!

# 4. Grants Report

- Grants report sent by Marianne Quellhorst via email on January 19th
  - Target Grant was approved and received (submitted by Marissa Albright on behalf of Boosters for soccer programs)
- Two previously submitted grants will only hear back IF we receive them
  - State Farm "Good Neighbor" financing for Orton Gillingham, decision in January
  - o Annie's Grant for Gardens fencing for the garden, decision in January
- Learning Links can submit up to two grants for these funds this year
  - o Funds available for grant was increased from \$1000 to \$1250
    - Jackie brought up Ms. Kate's fossil station work for her Master's Degree program as a possible idea
    - Emma mentioned meeting with Ms. Simpson and Ms. Johnson to see if they have any ideas
- Dollar General Literacy Grant
  - Have received in the past with help from Marcy Berns
  - o Any needs for upcoming school year, needs to be literacy focused

#### 5. New Business

- Flower Sale Elizabeth Johnson and Lindsay Felder championing
  - Will be done completely online this year
    - Could be an opportunity for continued Cookbook sales as well as Buddy Cards
- Individual Classroom Support Requested at 6-9 level
  - o Teacher has asked for assistance with purchasing classroom materials
    - Emma will bring her request to Ms. Simpson and Ms. Johnson before foundation can approve use of any funds for materials
- Future Funding Requests
  - Ms. Simpson and Ms. Johnson should be approached with all funding needs before coming to foundation to ask for money
    - Foundation will also ask Ms. Simpson and Ms. Johnson for input before granting approval of funds
    - This is different than money that is already budgeted for use
